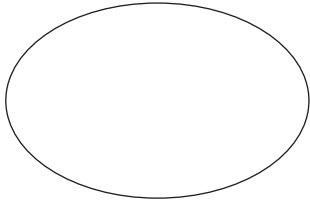

- Corrections/overwriting in both plot registration requisition form as well as thumb impression form is strictly not acceptable

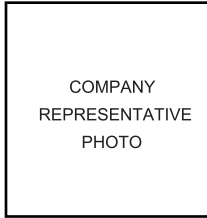
